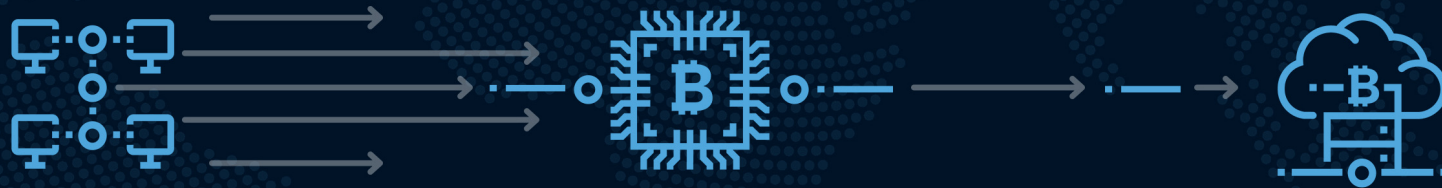

ORDER TYPES

Fintorex provides a large variety of order types for an effective implementation of trading strategies

1

Market order

A market order is a buy or sell order which is executed at current market prices if there are buyers or sellers who are willing to fill it. Market orders are used when the price is not a priority and there is need to get an execution.

2

Stop

A stop order, also known as a stop-loss order, is an order to buy or sell when price reaches a specified level. Once the stop order has been triggered, it turns into a market order, which is filled at the best possible price.

3

Trailing Stop

Trailing stop is stop order that can be set at distance from price which is nominated either in percentages or asset amount. This type of order is designed to protect gains by keeping stop order at specified distance from price when it moves in favorable direction.

4

Limit Order

A limit order is an order to buy or sell at a specified price or "better. This gives the trader control over the price at which the trade is executed and fees. On the other hand, limit orders might never be filled.

5

Fill or Kill

This is a type of limit or market order that must be executed fully, otherwise it will be immediately cancelled. The idea behind fill or kill order is to make sure that the order receives specified or best market price without partial execution.

Stop Limit Order

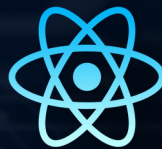
Stop limit order is an order that allows to place limit order if certain price level is triggered. It requires to set two price points. First is a trigger price, which allows to activate limit order. Second is limit order price.

PLATFORM FOR MONEY MANAGERS AND INVESTORS

The platform for money managers and investors (PMI) is a technical solution provided to Fintorex clients that. It allows investors to have their accounts managed by a money manager appointed by them on the basis of a limited trading power of attorney

PMI solution allows money managers to manage simultaneously unlimited quantity of investors' accounts on a single trading account. Managed accounts can be funded in different currencies. Depending on the size of the deposit each managed account has its own ratio in PMI. Total sum of all ratios under one PMI account is always equal to 100%. Money manager's results (trades, Profit & Loss) are automatically allocated between managed accounts according to ratio.

INVESTORS

PMI is a simple, hassle-free method for individuals to find their crypto asset managers for trading. With this platform investors benefit from profits with minimal involvement.

INVESTORS

Individuals are able to choose from number of investment propositions using built-in dashboard and screening tool. Each investment proposition includes unified parameters such as volatility (beta), past performance over number of periods, sharp ratios and many others as well as detailed description of investment product.

In this case investors are able to make an informed decision and compare different investment products as well as build their own portfolio.



PRODUCT PROVIDERS

The platform allows creation of investment products by third parties, individuals as well as organisations, and they can list them on Fintorex investment platform.

The platform supplies environment and tools to users for creating investment products. Product providers are able to use market data and backtest their products within investment platform.

INVESTMENT PRODUCTS TYPES

Fintorex investment platform provides a few categories of investments which can include dozens of products



Portfolios

Fintorex investment platform provides option for investor to select his/her own portfolio. Investors are able to create their own portfolios from cryptocurrency, crypto funds and other investment products provided on the platform.

Crypto Index

The purpose of crypto index products is to provide a way to track the performance of crypto markets or get exposure to a particular market segment. The historical performance of similar products have consistently beaten the average managed fund on traditional financial markets.

Crypto fund

This category of investment products specializes preliminary on ICO tokens and is intended to address the main issues of the current tokenized investment vehicles, such as: lack of diversification, lack of standardization and high risk. This crypto fund category has its own parameters such as investment horizon, amount of investment under management (AUM) similarly to classical closed and open end funds structure, past performance, list of constituencies, type of management (passive, active). However, Crypto fund can include trading strategies, cryptocurrencies and structured products.

Structured products

A structured product is a type of product which would include investment strategy based on a single cryptocurrency, a basket of cryptocurrencies, crypto indices, crypto instruments with fixed yield and crypto futures. The variety of products just described is demonstrative of the fact that there is no single, uniform definition of a structured product. They also can include parameters such as expiration day. Due to limited number of crypto asset types, unlike in traditional financial market, this type of products might still be considered as a work in progress.

INVESTMENT PRODUCTS QUALITY CONTROL

Product creators are able to list their investment product on the platform only after a quality check by Fintorex investment team



This offers the opportunity to obtain an in-depth analysis of the inner workings and mechanisms of an investment product.

Generally, this includes assessment of the likelihood of the product achieving its target or fundamental facts that explain the price behavior during the lifetime of the product.

The evaluation can also be extended into the analysis of a particular investment theme or the investment style of a specific investment product provider in order to include additional parameters and ratings for more precise evaluation.

PRODUCT PROVIDERS AND INVESTORS

Fairness and transparency are primary principles for building strong and successful business relationships



Fintorex investment platform takes on a role of mediator to ensure fair and transparent relationships between two parties.

Those principles are enforced by business logic which is in built into the platform.

Investors have option to choose among variety of investment products which have different terms and conditions. It is sole responsibility of investor to understand all the nuances of the investment product and if he/she agrees to them then the platform enforce agreements. The same happens for product provider.

Regulatory framework includes regulations of fee deduction P&L sharing, period of investment and fees for early exit. All fees are deducted automatically from each party. Product providers must reserve certain amount of money which can be nominated in a few different cryptocurrencies.
